THE BELOW REFERENCED INDIVIDUALS WILL BE PRINCIPALLY DESIGNATED PERSONS RECOGNIZED BY THIS AGREEMENT TO ASSIGN UNIVERSAL TOWING INC AND ITS AGENTS TO LAWFULLY REMOVE ANY AND ALL UNAUTHORIZED

VEHICLES FROM THE REFERENCED SITE. THIS IS A NON-BINDING CONTRACT THAT CAN BE CANCELLED AT ANY TIME WITH A 30 DAY WRITTEN NOTICE. THIS AGREEMENT WILL SERVE AS CLIENT'S AUTHORIZATION FOR UNIVERSAL TOWING INC TO ACT AS ITS AGENT IN THE REMOVAL ON SIGHT OF ANY AND ALL UNAUTHORIZED VEHICLES THAT ARE COVERED BY THIS CONTRACT. CLIENT REPRESENTS AND WARRANTS THAT IT HAS THE RIGHT TO AUTHORIZE AND EFFECT SUCH IMMEDIATE REMOVAL OF VEHICLES FROM ITS PREMISES. FURTHERMORE, CLIENT AGREES TO INDEMNIFY AND HOLD UNIVERSAL TOWING INC HARMLESS FROM AND AGAINST ANY AND ALL CLAIMS, ACTIONS, LAWSUITS, LOSSES, DAMAGES AND/OR LIABILITIES, INCLUDING ATTORNEY'S FEES AND COSTS OF DEFENSE, WHICH MAY ARISE PURSUANT TO THIS AGREEMENT, EXCEPT IN THE CASE OF ANY DAMAGES TO A VEHICLE CAUSED SOLELY BY THE GROSS NEGLIGENCE AND/OR ILLEGAL CONDUCT OF UNIVERSAL TOWING INC OR ITS AGENTS.
